Development GFL Environmental

Further to the previous meeting and the Contract presented to The Summer Village from GFL Environmental for the door to door waste pickup Mr. Donini agreed to attend the meeting to go over the contract. New Contract is for \$11.87 x 124 bins a month = \$1471.88 This contract is from January 1, 2017 to December 31, 2020. A 5% increase will be added yearly starting January 2018 = \$12.46 x 124 bins = \$ 1545.04

January 2019 = \$13.08 x 124 bins = \$ 1621.92

January 2020 = \$13.74 x 124 bins = \$ 1703.76

The existing contract is for $$12.50 \times 124 = 1550.00 with no increases for 60 months - September 1, 2015 to August 31, 2020

- b) Jason Madge Jaymadcontracting Email Dated December 23, 2016, Proposal for Regional Public Works Manager. Mr. Madge is offering management services for projects such as working with contractors and engineers, assist with drainage planning, assist with capital planning etc. Costs vary from \$200.00 monthly retainer to \$120.00 an hour. (*Discussion at meeting time*)
- c) Administration is proposing changing bank accounts over to ATB. At present the CIBC is charging a once a year loan fee of \$350.00 and a \$75.00 a month loan operating loan fee just to have the operating loan available for use.

 Along with that Administration would like authority to set up online tax payment with the banks that only charge a onetime sign up fee and no monthly fees. (council recommend administration start the process of change banking authorities)
- d) Town of Mayerthorpe Karen St. Martin CAO, Letter dated January 26th, 2017 which includes the AFRRCS Third Party Agreement. This is all part of the Regional Radio Project and the Town of Mayerthorpe has offered to host the required license with the Province on all members behalf. (for Council approval and to execute the AFRRCS Third Party Agreement)
- e) 2017 Summer Village Election As per the act, Summer Village's need to hold their nomination and election during July and August. We are suggesting that we pick dates and times now. Nomination day is from 10:00 a.m. to noon four weeks prior to Election day. Council has the option to set an advanced vote as well. (Set dates, times and locations)
- f) FCSS Shelley Vaughan email dated January 24, 2017, Providing the spread sheet of the Municipalities and their contributions and requesting where/how the Sunrise portion should be spent. (suggest projects for FCSS funding)
- g) Lagoon Administration Further to the last Joint Lagoon Meeting Administration would like some direction from Council. Attached are the emails from Jason Madge regarding training for the Lagoon operator and C. Caron Administrator Sandy Beach regarding the operator fees. (looking for direction from Council)
- h) Draft Budget Review The first Draft Budget for 2017 is attached and will be reviewed at meeting time. (accept draft budget as presented)

- i) Bylaw Tickets for Officer Tom Puffer Animal Bylaw Officer has requested The Summer Village purchase bylaw ticket books for his use. Administration has requested a price from Marcel's printing. At the time the agenda was being printed the quote had not been received. (consider putting ticket purchase in budget if received by then)
