## **BYLAW NO. 99-2004**

A BYLAW OF THE SUMMER VILLAGE OF SUNRISE BEACH, IN THE PROVINCE OF ALBERTA, TO ESTABLISH A SUBDIVISION AND DEVELOPMENT APPEAL BOARD IN ACCORDANCE WITH THE PROVISIONS OF THE MUNICIPAL GOVERNMENT ACT.

WHEREAS, Section 627 of the Municipal Government Act, R.S.A. 2000, requires each municipality to establish a Subdivision and Development Appeal Board,

**NOW THEREFORE**, the Council for the Summer Village of Sunrise Beach hereby establishes a Subdivision and Development Appeal Board in accordance with the following provisions:

- 1. That the Board known as the Subdivision and Development Appeal Board for the Summer Village of Sunrise Beach (hereinafter called "the Board") is established.
- 2 The Board shall be comprised of members of the Joint Appeal pool established through agreement with Summer Villages within Lac Ste. Anne County;
  - a) The Summer Village shall supply a minimum of one (1) member, appointed by resolution of Council, to the Joint Appeal pool;
  - b) No person who is a Development Officer or a member of a Municipal Planning Commission shall be appointed to act as a member of the Joint Appeal Board;
  - c) Each member shall be appointed for a term not exceeding three (3) years and may be re-appointed upon the expiry of its members;
  - d) Any vacancy caused by the death, retirement or resignation of a member shall be filled by resolution of Council;
  - e) A member shall not be disbanded or discharged without cause.
- 3 A quorum at any one meeting of the Board shall include a minimum of three (3) members.
- 4 Only those Members of the Board present at a meeting of the Board may vote on any matter before the Board.
- 5 The Board shall prepare and maintain a record of written minutes of the business transacted at the meetings of the Board.
- 6 The Board shall hold such meetings as are necessary to fulfill the Board's responsibilities.
- 7 The Board shall conduct its meetings in a manner consistent with the provisions of this Bylaw, the Land Use Bylaw, any relevant Statutory Plan, and the Municipal Government Act, R.S.A., 2000.
- 8 The remuneration, traveling, and other expenses of the Board members and the Secretary of the Subdivision and Development Board shall be established by the Summer Village of Sunrise Beach Council.
- 9 The setting of fees for any matter coming before the Board shall be established by the Summer Village of Sunrise Beach Council.
- 10 The refunding of any fees for appeals heard by the Board shall be at the discretion of the Summer Village of Sunrise Beach Council.
- 11 The Board shall elect a Chairperson from among those members of the Board who are in attendance for a meeting of the Board.

- 13 The administrative function of all appeals shall be performed by the Secretary of the Subdivision and Development Appeal Board.
- 14 The Secretary of the Subdivision and Development Appeal Board shall be the Municipal Administrator of the Summer Village of Sunrise Beach or his/her designate. The Municipal Administrator may designate a Secretary of the Subdivision and Development Appeal Board as required.
- 15 A person with decision-making authority for any matters before the Board shall not be a Secretary of the Subdivision and Development Appeal Board.
- 16 This Bylaw comes into effect on the date of its final reading.
