- a) FCSS Remaining Funds for 2017 currently Sunrise Beach has spent \$4,097.00 of their FCSS funds leaving \$1,593.39 yet to be spent. Does Council have any other ideas for their \$1,593.39? The money has to be spent by the organizations by December 31, 2017 and must fit the criteria for FCSS spending. Attached is a proposal from Jim Schulte, President of the Stettin-Nakamun Community Hall and a Barriers Removed Group looking for another \$3524.41 of the \$5,957.60 dollars, they need. - c) ASVA Beverly Smith Executive Director Email Dated September 14, 2017
 To cover increasing costs due to the fact that executive is becoming more involved by providing valuable input at various government levels, ASVA is increasing membership fees by \$50.00 in 2018. In 2017 Sunrise Beach paid \$558.00 in dues

to the ASVA which is based on Residential Equalized Assessment from the Municipal Affairs Website x .0242 mills. (*Comment back to ASVA or accept as information*).

- d) Bylaw 139-17 Fortis Franchise Agreement has been approved by the Alberta Utilities Commission and now requires the 3rd reading. At your May meeting it was moved to approve the franchise agreement with FortisAlberta for a 10 year term and 0% franchise fee. The first and second readings passed in May and June respectively. The third reading is required at this time. (Approve 3rd Reading for Bylaw 139-17)
- e) Sturgeon County Fire Agreement Attached is the new Sturgeon County's Fire Service Agreement. The changes are highlighted in yellow and the agreement that is expiring in December 2017, is attached as well. The new agreement terms are for 2 years, 2018 2020, and the fee remains at \$2000.00 per year for the Summer Village. Schedule B Fees for Service 2a. was \$610.00 and is now \$615.00 an hour for each piece of fire apparatus and 2b. was \$180.00 and is now \$185.00 an hour for each command vehicle. These charges would be charged to the resident.
