## 6. New Business/Action Items

a) Director of Emergency Management – currently the DEM & Assistant DEM is your administration. These names were put in place just to get the positions filled for the time being. Administration is suggesting consideration be give to appointing Shari Ives as DEM. Her proposal is attached and has an annual cost of \$4,760.00 which includes: annual community disaster plan review, fire and emergency services bylaw review, wildfire preparedness/fire smart planning, liaising with mutual aid partners and agencies, liaising with municipal departments, performing or participating in a mock table top disaster exercise, reporting before council. The Summer Village is legislated to ensure we have this in place, and ensure we are fulfilling our expected requirements. This proposal is for an active and engaged DEM totaling \$4,760.00. Administration is suggesting that either you look at the contract as a whole or that Council consider contacting Ms. Ives if she would consider a partial contract with items that are most important at the

present time. (that the Summer Village of Sunrise Beach contact Shari Ives as Director of Emergency Management and propose a partial contract that includes \_\_\_\_\_\_, hire her for the whole contract, search for a resident who many have some experience and want to take this on, or some other direction as given by Council).

- b) Borrowing Bylaw -141-18 For the purpose of borrowing funds to meet current Capital Expenditures & Obligations from the ATB for the Summer Village of Sunrise Beach. This Bylaw replaces Bylaw 140 -17 which did not specify a revolving loan but the principal amount in full. (Pass all readings for this bylaw).
- c) Bylaw 142 18 For the purpose of Regulating and Controlling Animals within the Corporate Limits of the Municipality. Page 3, Section D,e) i Add the word "barking" between "biting" and "or" so that the bylaw is consistent with the remaining items in that section. This Bylaw would replace 108-2007. (*Pass all readings for the amended bylaw*).
- d) Sunrise Beach 2018 Interim Operating Budget as the municipality does not pass its annual operating budget until Spring, we need to approve at the first meeting of the year an Interim Operating budget based on one half of the previous year's operating budget. (That the Summer Village of Sunrise Beach approve a 2018 Interim Operating Budget based on one half of the 2017 Operating Budget and that this 2018 Interim Budget cease to have any effect once the 2018 Operating and Capital Budget is approved).
- e) Forest Resource Improvement Association of Alberta (FRIAA) Email dated December 19, 2017. Information on "Requesting interest for FRIAA FireSmart Programs". Attached is the grant information, which is a two part process. The first is an expression of interest and if you are approved then the second part will be applied for. Closing date for the first grant is February 28, 2018. (Further discussion and direction at meeting time).

Administration contacted Morinville RCMP to get some information the programs but did not receive any information by the time the agenda was being printed. (more information at meeting time).
