- a) 2017 Audited Financial Statements and Audit letter to Council Attached are the highlights for the 2017 audited Financial Statements as prepared by Hawkings Epp Dumont, include a \$141,736.00 decrease prior to amortization, and this is reflected on page 4, 5 and then again on page 12 where you will see your unrestricted surplus decreased from \$294,391.00 to \$152,564.00 and this as a result of the road project.
