
Pre-Authorized Tax Payment Plan (TPP)

It is important that the Summer Village Administration Office has your current mailing address. Without your current mailing address, your Tax notice may not be properly delivered and that could lead to delays & penalties.

COVID – 19 New Tax Penalties

In recognition of the extreme circumstances resulting from COVID-19 Pandemic the tax penalty structure will be amended for the 2020 year as follows:

August 1 - 1%

September 1-1%

October 1 through to December 1-3% each month

December 31, - 10% On all outstanding balances.

(In previous years the Tax Penalties were August 1 to December 1 – 3% and January 1, 18%)

PROPERTY TAXES

For the 2020 taxation year Council resolved that each property will be charged a \$920.00 Minimum Municipal Tax. The concept of the Minimum Municipal Tax is that each property, whether improved or vacant, whether there is a 2,000 square ft house or a smaller cabin, the same services are utilized (roads, streetlights, public works, assessment, administration, auditor, Council, etc.). As a result of this change, the lower-assessed and vacant properties will see an increase in their municipal tax dollars paid.

Your property taxes

The Summer Village collects revenues annually to meet the projected costs of providing services to the community. These revenues are received through grants, and the municipal portion of property taxes. Other amounts collected on your annual tax bill are collected on behalf of the Lac Ste. Anne Seniors Foundation and the Alberta School Foundation Fund.

Combined Assessment & Property Tax Notices are mailed out May 15th, 2020.

Property taxes are due July 31st, 2020.

The assessment value amount that is on your notice is an estimate of the market value of your property as of July of 2019. The assessor used sales leading up to July of 2019 to establish the assessments. This is prior to the Covid-19 pandemic and the collapsed economy and, unfortunately, can not be changed due to Provincial regulations which govern property assessment.

At this point it is unknown how the loss of employment, the closing of businesses, and/or other economic factors will affect real estate market values and, therefore, future assessed values. Assessors are bound by strict guidelines for assessment and will be ensuring everything possible is taken into consideration for the future.

You are encouraged to talk to an assessor if you have concerns about the assessment as it relates to your property value in July of 2019. Please contact the municipal office who will put you in touch with an assessor. Please also keep in mind that the assessor does not set the tax rates in the municipality, and therefore cannot answer questions about property taxation. Nor can they answer questions about the amount of services you receive. For tax rate questions, for questions about services, or for general inquiries please contact your municipal office.

What If I Disagree with My Assessment?

Remember, you can only make a complaint against your assessment value, not your tax dollars or rates and you must have grounds for your complaint. New legislation allows you 60 days from the date of your assessment notice to make an assessment complaint.

The assessment complaint deadline for the Summer Village is July 24, 2020 There is a fee of \$50.00 that must accompany a completed assessment complaint form which is available on the website www.summervillageofsunrisebeach.ca or by contacting the office at 780-967-0271. 
It is anticipated the truck fill station for Sunrise and Sandy Beach will be constructed in 2020 barring any unforeseen delays due to Covid 19.
