NOTICE OF SENATE ELECTION AND REFERENDUM QUESTIONS VOTING

In reference to the above noted, please be advised that under the provisions of the Alberta Senate Election Act and the Referendum Act the Summer Village of Sunrise Beach is hereby providing the prescribed Notice of Election.

Operating slightly differently than the municipal election held earlier this year, the Senate and Referendum Vote is being conducted in coordination with the Town of Onoway (our designated municipal partner for the purpose of this election) and is open for participation by eligible electors residing in the summer village. This means that voting will occur on the same day as Alberta's general municipal elections and it means that you may only vote if you are a <u>resident</u> of the summer village. For clarity, all eligible electors must vote in the location where they designate their residency, and each elector may only vote once throughout the province in this election.

Form 7RSE is attached for your official notice, as well as some additional information regarding the senate candidates, referendum questions, and voter identification guidelines. Additional information is available via the Elections Alberta Website at:

Voting will occur on **Monday October 18th, 2021 from 10:00am through 8:00pm**, and will be held at the **Onoway Heritage Centre** (4708 Lac Ste. Anne Trail North, Onoway Alberta T0E 1V0). No provisions have been made for advance voting or special ballots in this election.


Authorized Identification

E-20-301 Election Act Section 95

When registering to vote, you must show identification to prove your name and your current physical address.

Choose from one of the three ID options:

- Show a copy of your *Alberta Driver's Licence* or your *Alberta Identification Card* with your name and current physical address;
- Show a copy of **two pieces of identification**, both with your name and with one piece showing your current physical address, from the list below:
