

2025 General Election Clarification of Elector Eligibility – Summer Villages

Re: Eligibility to Sign Nomination Papers

Please note that in accordance with **Section 12** of the *Local Authorities Election Act*, elector eligibility in a **Summer Village** differs from other municipalities.

An individual is eligible to vote—and therefore eligible to sign nomination papers—in a Summer Village election if they meet the following criteria:

- 1. the person is eligible to vote under section 47,
- 2. the person is 18, a Canadian citizen and is named on a certificate of title as the person who owns property within the summer village, or
- **3.** the person is 18, a Canadian citizen and is the spouse or adult interdependent partner of a person referred to in subclause (ii)

Residency in the Summer Village is not required for elector eligibility.

This note is provided to clarify that **non-resident property owners who meet these requirements may legally sign nomination papers** under the LAEA, even though the standard form includes a reference to "resident in the local jurisdiction."
